Thank you for your interest in ICurrant!

Please read these Terms of service carefully as they contain important information regarding your legal rights, remedies, and obligations. These include various limitations and exclusions, a clause that governs the jurisdiction and venue of disputes, except where prohibited, an agreement to arbitrate on an individual basis (unless you opt out), and obligations to comply with applicable laws and regulations.

INTRODUCTION

Currant LLC., for and on behalf of its subsidiaries (collectively, "ICurrant", "we", or "us"), provides an online product rental platform, that connects renters with users, who want rent. ICurrant is accessible online at icurrant.com. ICurrant's websites and associated services are collectively referred to as "the Services". By accessing or using the Services, including by communicating with us or other ICurrant users, you agree to comply with, and be legally bound by, the provisions of these Terms of Service ("Terms"), whether or not you become a registered user of the Services. These Terms govern your access to and use of the Services and constitute a binding legal agreement between you and ICurrant.

These Terms, together with ICurrant's Privacy Policy, and the user Policies accessible via the Services (the "Policies") constitute the "Agreement" between you and ICurrant (each a "Party" and together, "the Parties").

ELIGIBILITY

Our Services are intended solely for persons who are 18 or older. Any use of the Services by anyone under 18 is expressly prohibited.

REGISTRATION

To access certain features of the Services, you must sign up for an account with us (a "ICurrant Account") by either providing us your email address and creating a password or connecting through an account with a third-party site or service (including Facebook and Google).

VERIFICATION

When you list your product for rent, you may provide us with certain information about yourself to enable us to verify your identity in order to become an "Approved User". You promise to provide complete and accurate information to ICurrant about yourself, if applicable.

Where permitted, ICurrant has the right, but not the obligation, to undertake screenings, checks, and processes designed to help verify or check the identities and/or backgrounds of users.

ICurrant does not endorse any user, or a user's background, or commit to undertake any specific screening process. ICurrant may in its sole discretion use third party services to verify the information you provide to us and to obtain additional related information and corrections where applicable, and you hereby authorize ICurrant to request, receive, use, and store such information.

YOUR COMMITMENTS

You agree that you will always use your ICurrant Account and the Services in compliance with these Terms, applicable law, and any other policies and standards provided to you by ICurrant.

Violate any law, including:

- breach, violate, and/or circumvent any local, state, provincial/territorial, regional, or national law or other law or regulation, or any order of a court, including, without limitation, airport regulations and tax regulations, licensing or registration requirements, or third party rights;
- post false, inaccurate, misleading, defamatory, or libelous content;
- infringe, reproduce, perform, display, distribute, reverse engineer, or prepare derivative works from content that belongs to or is licensed to ICurrant, or that comes from the Services and belongs to another ICurrant user or to a third party, including works covered by any copyrights, trademark, patent, or other intellectual property, privacy, publicity, moral, or contractual rights, except with prior express written permission of ICurrant;

Dilute, tarnish, or otherwise harm the ICurrantbrand in any way, including:

- through unauthorized use of ICurrant and/or user content;
- registering and/or using ICurrant or derivative terms in domain names, trade names, trademarks, or otherwise;
- registering and/or using domain names, trade names, trademarks, social media account names, or other means of identification that closely imitate or are confusingly similar to ICurrant domains, trademarks, taglines, promotional campaigns, or ICurrant and/or user content.

Provide or submit any false information, including:

- false name, date of birth, payment method, credit card or other personal information;
- a claim, or respond to a claim, with false or misleading information;
- any listing with false or misleading information, or any listing with a price that you do not intend to honor;
- register for a ICurrant Account on behalf of an individual other than yourself;
- impersonate any person or entity, or falsify or otherwise misrepresent yourself or your affiliation with any person or entity;

Use the Services for your own unrelated purposes, including to:

- commercialize any content found on ICurrant or software associated with our Services, including reviews;
- harvest or otherwise collect information about users without their and our consent;
- recruit or otherwise solicit any user to join third party services or websites that are competitive to ICurrant, without ICurrant's prior written approval;

ICurrant has the right, but not the obligation, to investigate, pursue, and seek to prosecute, litigate, or refer to law enforcement, violations of the Agreement to the fullest extent permissible by the law. ICurrant may access, preserve, and disclose any of your information if we are permitted or required to do so by law; if we believe in good faith that it is reasonably necessary to respond to claims asserted against ICurrant or to comply with permissible legal process (for example, subpoenas or warrants); to enforce or administer these Terms; to do so for fraud prevention, risk assessment, investigation, customer support, product development, and debugging purposes; and/or to protect the rights, property, or safety of ICurrant, its employees, its users, or members of the public.

ICurrant reserves the right, at any time and without prior notice, in accordance with applicable law, to remove or disable access to any content that ICurrant, at its sole discretion, considers to be objectionable for any reason, in violation of this Agreement, or otherwise harmful to the Services or our community. If we believe you are abusing ICurrant, our users, or employees in any way or violating the letter or spirit of any of this Agreement, we may, in our sole discretion and without limiting other remedies, limit, suspend, or terminate your ICurrant Account(s) and access to our Services, remove hosted content, deny a claim for coverage, remove and demote your listings, reduce or eliminate any discounts, and take technical and/or legal steps to prevent you from using our Services. Additionally, we reserve the right to refuse or terminate our Services to anyone for any reason at our discretion to the full extent permitted under applicable law.

POLICY ENFORCEMENT

When an issue arises, we may consider the user's performance history and the specific circumstances in applying our Policies. We may choose to be more lenient with policy enforcement in an effort to do the right thing, subject to our sole and absolute discretion.

DATA PROTECTION NOTICE

Any personal data that you supply to the ICurrant or authorize the ICurrant to obtain from a third party, for example, a credit card company, will be used by ICurrant to administer the datas. In order to process, record and use your personal data ICurrant may disclose it to

- any credit card company whose name you give;
- any person to whom ICurrant proposes to transfer any of ICurrant's rights and/or responsibilities under any agreement ICurrant may have with you;
- any person to whom ICurrant proposes to transfer its business or any part of it;
- comply with any legal or regulatory requirement of ICurrant in any country; and prevent, detect or prosecute fraud and other crime.

In order to process, use, record and disclose your personal data ICurrant may need to transfer such information outside the United States, in which event ICurrant is responsible for ensuring that your personal data continues to be adequately protected during the course of such transfer.
